(1) Unrestricted accounts leave decision regarding use of annual income/distribution to the discretion of PHUMC Foundation. Income/distributions from restricted accounts have been designated for a specific purpose by the donor.

(2) 4% of unrestricted account values transferred annually to PHUMC Unrestricted Spending Account and is available for distribution, except for Gaston and Vinton which have unique donor instructions. See (4) & (5) below.

(3) Agency accounts are owned by PHUMC Foundation and are assigned to MFA for investment management. Trustee accounts are owned by MFA and designate PHUMC as a beneficiary.

(4) Gaston: Dividend & interest income distributed annually to PHUMC.

(5) Vinton: 40% of dividend & interest income transferred to principal, 60% transferred to PHUMC Unrestricted Spending Account.

(6) Per PHUMC instructions, annual scholarship distribution is \$4,000.

(7) Per PHUMC instructions, annual distribution is \$500 to Youth Ministries.

(8) As of 01/2015, 4% spending rate has been transferred to these spending accounts based on a 12-quarter average FMV from corresponding endowments, with the exception of Sullivan.

(9) Sullivan: 5% spending rate distribution will be transferred to a restricted spending account after balance has reached \$50,000.
